- **1. QUALIFICATION:** A Post Graduate Degree i.e. MD/MS/DNB/DM/M.Ch or equivalent in the above Department recognized by Medical Council of India / NMC/NBE.
- a) For Clinical Haematology, candidates with MD in General Medicine and MD in Paediatrics are also eligible to apply.

Note: All PG Students who have passed their final examination in December 2024 session are also eligible to apply.

2. AGE LIMIT

The upper age limit for applying these posts is 45 years as on last date of application.

Ex-servicemen/Women/PwBD candidate is exempted from any fee.

Also make sure to get the confirmation of the successful remittance by your bank and retain the proof of the same which may be required at the time of document verification. The application fee is non-refundable.

- (k) Online payment of fee: Once a candidate clicks on button for making the payment, they will be redirect to the Payment gateway site. There are various options available for payment viz. Internet Banking (major banks) & Debit/Credit Cards. Additional charges viz. bank charges, service tax etc. incurred while making online payment of application fees will be borne by the candidate. After making the successful Payment they will immediately be redirected to (www.aiimspatna.edu.in) for generation of Registered Application Form. 9. SELECTION PROCESS:

- a) Written test (MCQ based) will be held for selection to the advertised posts of Senior Residents.
- b) Total Number of questions will be 100, carrying one marks each. There will be no negative marking.
- c) Duration of written (MCQ based) examination will be 01 hours and 30 minutes.
- d) Qualifying marks for written test will be as under: UR: 50 % OBC-NCL/EWS: 45 % SC/ST: 40 %
- e) Final Selection list will be declared solely based on the marks obtained in written examination.
- f)While every effort will be made to intimate the candidates regarding Examination schedule at the earliest, the responsibility lies with the candidate to check for the same on the institute website. All Candidates must provide phone numbers and Email for faster communication at the time of application.
- g) Those who already completed 03 years of their Senior Residency are not eligible to apply.
- h) The final result will be displayed on the website i.e. (www.aiimspatna.edu.in).
